ABOUT IIM SHILLONG:

The Institute which has moved to its 120-acre state-of-the-art permanent campus in 2021, offers Master of Business Administration (MBA), Master of Business Administration for Executives (Executive MBA), Master of Business Administration for Working Executives (MBA-WE), Doctoral Programme (Ph.D.) in Management; Management Development Programmes and Faculty Development Programmes. The Institute also conducts several Certificate Programmes ranging from short-term to one-year duration and Skill Development Programmes for the youths of the North Eastern Region. ELIGIBILITY CONDITIONS:

- ❖ The applicant must be a distinguished academic with Ph.D. or equivalent having at least fifteen years teaching or research experience and shall have worked as a Full Professor at a reputed institution for at least seven years; or shall have industry experience at a higher level for at least fifteen years;
- ❖ Must be below the age of 65 years as on the last date of receipt of applications; and
- ❖ Must be an Indian citizen or Overseas Citizen of India (OCI).

PROCESS OF SELECTION:

In line with IIM Act 2017 and IIM Rules 2018, the Director will be appointed based on the recommendations made by the Search-cum-Selection Committee (SCSC). The SCSC will consider applications fulfilling the above criteria received in response to this advertisement as well as nominations received from eminent persons in the field of management / management education.

TENURE:

The selected candidate would have a tenure of five years or until he/she reaches the age of seventy (70) years of age of superannuation, whichever is earlier.

ENTITLEMENTS:

The Director shall be entitled to the Pay Scale in Level 17, the 7th CPC, as revised from time to time by the Government of India. The Director is also entitled to variable pay based as per IIM Shillong Regulation. The Director is also authorised to draw other allowances like Dearness allowance, etc., as may be admissible from time to time as per rules of the Government of India.

OTHER CONDITIONS:

- ❖ In case the applicant is employed in an organisation within the control of the Government, he/she must submit Vigilance Clearance Certificate along with the application.
- ❖ The application will be rejected if complete details are not provided in the application.
